RE: Petition for Residential Parking Permit Area (RPPA) Program for Brush Park
Pursuant to Chapter 55 of the 1984 Detroit City Code, as amended

Dear Ms. Winfrey:

As the Resident Petition Coordinator on behalf of the Certified Residents in the Brush Park community, enclosed please find our petition to implement the Residential Parking Permit Area (RPPA) Program for an area contained within the following boundaries (street and address range):

- Eliot Street from 206 to 324
- Erskine Street from 203 to 430
- Watson Street from 202 to 454
- Edmund Place from 39 to 321
- Alfred Street from 44 to 300
- Adelaide Street from 44 to 257
- Winder Street from 55 to 291

We are requesting these streets to be designated as part of an RPPA with restricted parking for permitted residents only from 7 a.m. to 10 p.m. weekdays and weekends. On-street parking for commuter vehicles and nonresidents would be prohibited during these hours. We have included a map with this letter to depict the proposed Residential District.

Further, to support the retail, commercial, and restaurant businesses in our neighborhood, we propose designating certain limited portions of the East-West street block faces as metered parking, specifically near the following locations:

- On Alfred Street near Brush Street
 - Business Name: Bodega
 - Business Address: 2671 Brush Street
- On Erskine Street near Brush Street
 - Business Name: Chili, Mustard, Onions
 - Business Address: 3411 Brush Street

We believe our neighborhood is disproportionately impacted by parking congestion caused by our proximity to Little Caesar's Arena, Comerica Park, Ford Field, and the Wayne State University Business School. We believe our neighborhood is eligible for consideration pursuant to the designation criteria in Sec. 55-2-24 of the ordinance:

- 1) It is the desire of the residents to establish a Residential District as demonstrated by the attached petitions;
- 2) The extent to which on-street parking is used (near 100% utilization);
- 3) The extent to which on-street parking in the area is used by people attending sporting and entertainment events (commuter vehicles rather than resident vehicles);
- 4) The limited availability to residents of off-street parking spaces given the historic nature of the Brush Park neighborhood and the reduced parking requirements of the recently-enacted Form Based Code;
- 5) The extent of the noise, pollution, increased traffic, and deterioration of the residential environment as a result of traffic congestion and insufficient residential parking in the area;
- 6) Utilization of nearly 100% of legal on-street parking spaces during peak periods;
- 7) The extent to which well over half of the current on-street parking spaces are used by nonresidents for more than two hours at a time;
- 8) At least 80% of the occupied frontage of each proposed street has a legal use of "residential";
- 9) Off-street parking options for residents is limited and/or cost prohibitive (hourly parking is available);
- 10) Hourly parking for events is available to nonresidents in nearby parking structures and lots (there are more than 7,000 parking spaces in the District Detroit);
- 11) New development projects in Brush Park continue to contribute to neighborhood density and increase the residential demand for parking and the Form-Based Code only required .5-to-1 parking ratio;
- 12) The special circumstances of Brush Park's proximity to sports and entertainment venues burdens our residential neighborhood with an overwhelming amount of nonresidential traffic and parking demands; and
- 13) Designation of an RPPA in Brush Park will result in:
 - i. A reduction in nonresidential vehicles;
 - ii. A reduction in total vehicle miles driven;
 - iii. A reduction in traffic congestion and illegal parking; and
 - iv. An improvement in vehicle and pedestrian safety.

We respectfully request that you instruct the Director of the Department of Public Works to complete a preliminary analysis within ten (10) days to confirm that our request is reasonable and merits further analysis pursuant to the ordinance. 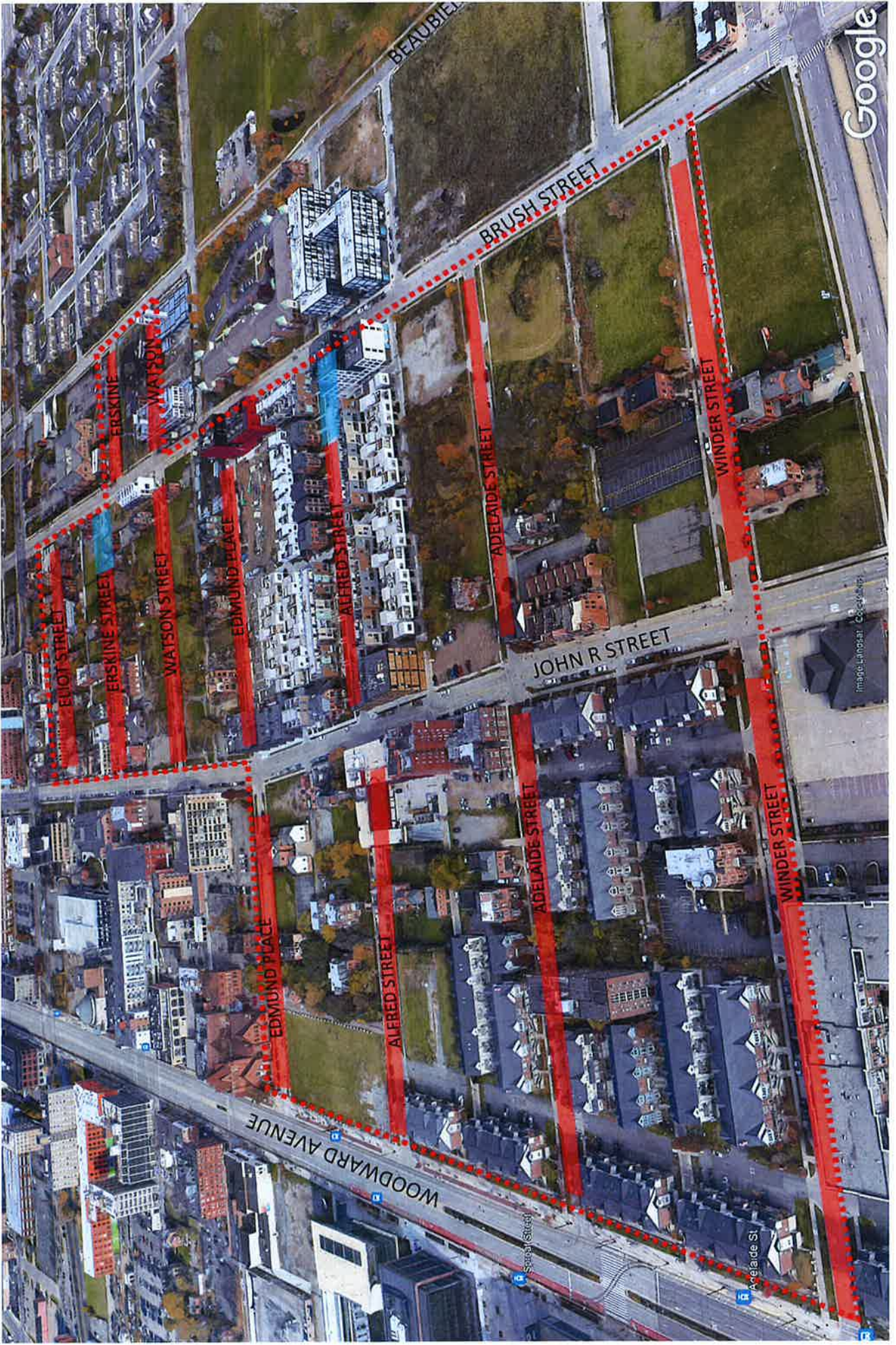

BRUSH PARK RESIDENTIAL DISTRICT













